4.2 Most important symptoms and effects, both acute and delayed

Inhalation of vapors may cause the lower and upper respiratory irritation, cough and breathing difficulty. At higher concentrations can cause pulmonary edema.

The contact of the product with skin causes sensitization (dermatitis). Dermatitis derives from skin inflammation that begins in the skin areas that come in contact with the sensitizing agent. 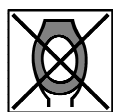
